



RegSol - Privacy Statement

RegSol is an initiative of the Orde van Vlaamse Balies (OVB) and the Ordre des barreaux francophones et germanophone (OBFG).

As specific data is processed as part of RegSol, this document provides specific information that complements DP-A's general privacy policy.

RegSol is a platform that digitises the exchange of data between the actors in insolvency cases.

All creditors (suppliers, banks, social security etc.) in a bankruptcy file must declare their claims digitally via [regsol.be](#).

The administrators manage the bankruptcy files online. They upload the required documents and sign them digitally via [private.regsol.be](#).

The uploading of documents in a judicial reorganisation procedure by actors involved in the procedure (debtors, creditors, delegated judges etc.) is also done digitally via [regsol.be](#) or [private.regsol.be](#).

Courts and tribunals (including justices, judges, supervisory judges, delegated judges and clerks) can also upload and sign judgments, orders and so on through RegSol.

OVB and OBFG are responsible for archiving the insolvency files. This eliminates paperwork and relieves the burden on court clerks.

THE IMPORTANCE OF DATA PROTECTION

Regsol attaches great importance to the proper protection of the data it processes, and to personal data in particular. In this respect, Regsol takes into account all the requirements laid down by the European legislation currently in force, in particular

Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation)
